No.GG/GUJ/30/2016/MHK/1010/1393/C:- In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951 (Bom. XXII of 1951), section 21 of the Gujarat State Reserve Police Force Act, 1951 (Bom. XXXVIII of 1951) and sub-section (1) of section 59 of the Prisons Act, 1894 (IX of 1894), the Government of Gujarat hereby makes the following rules further to amend the Police Constable, Class III, (Combined Competitive Examination) Rules, 2016, namely:-

1. These rules may be called the Police Constable, Class III (Combined Competitive Examination) (Amendment) Rules, 2016.
2. In the Police Constable, Class III, (Combined Competitive Examination), Rules, 2016, in rule 5, for clause (a), the following clause shall be substituted namely:-

(a) The Board shall, on receiving the requisition from the Director General and Inspector General of Police, Gujarat State, Gandhinagar, publish an advertisement in the prominent newspapers widely circulated in the State, inviting applications in the prescribed form, from the eligible candidates for appointment to the posts.
